Canberra is the capital city of Australia and the seat of Federal Parliament. Australia is governed under the Westminster system and is totally responsible for its own laws and judicial system.

The States are responsible for state laws and taxes and their parliaments have a house of representatives and senate.

currency



Australia's currency is the Australian dollar - AUD. The current exchange rate for the AUD to the USD\$ is 0.98 to the Euro is 0.74

The Reserve Bank of Australia sets Australia's monetary policy.

Australians have goods & services tax (GST) & a Medicare levy for the healthcare system (Australian residents only).

A Pay As You Earn tax system applies for wage earners.

healthcare services

Australian residents pay a Medicare levy for the provision of public health care. High income earners are encouraged to have private health insurance or pay an additional levy. A rebate applies to private health premiums and lower rates apply to people joining the healthcare funds before the age of 30 years. Healthcare is available through public and private hospitals, day procedure units and general practitioners.

Non-residents are advised to have appropriate insurance cover for medical expenses.
